Credit Agreement

- The undersigned grants A1 Rental permission to investigate/verify credit information.
- The undersigned grants A1 Rental permission to report to proper agencies and/or credit bureaus the performance of this agreement.
- The undersigned acknowledge the terms of this agreement. Any amount past due will be assessed a 2% service charge per month (Annual Rate 24%). Net 30 days from billing date of invoice.
- By executing this Credit Application/Contract, the undersigned jointly and severally if more than one (1), agrees to comply with all provisions thereof and to pay all sums and charges on this or any account opened and/or maintained in my name, including purchase cost of materials, and service charges, whether incurred by me or by my agents.
- This agreement, and any amendment thereto, is subject to credit approval. Any amendments to, or deviations from, this agreement must be in writing. This agreement supersedes all prior agreements, unless otherwise stated, and governs all purchases made to date and after the above date.
- If customer issues purchase orders or other documents relating to any purchases, and any terms thereof conflict with the terms herein, the terms and conditions of this agreement shall govern.
- Delivery of equipment to the construction site constitutes delivery to customer, regardless of whether customer or his agent is at the site at time of delivery. A1 Rental shall not be responsible for failure or delay in delivery. Customer waives any claims for damages arising by virtue of delay in delivery of equipment by A1 Rental, regardless of cause of delay.
- In the event a construction lien is filed against a project, all discounts are subject to revocation at discretion of A1 Rental. All discounts are applicable so long as customer's account with respect to any purchases is not in default.
- All claims for shortages or improper delivery must be made in writing within five (5) days of delivery. Any claims for adjustment or corrections of billing, must be made within five (5) days of receipt of invoice.
